## **ARTICLE II, Section 1.**

(g) **Salesperson:** Every salesperson in good standing, employed in a Manhattan office of a Broker A Member, and applicants of the Residential Brokerage Division who are employed in other jurisdictions authorized by the Residential Brokerage Division, and whose application is endorsed by his employer or employing firm, shall apply for election as a Salesperson Member and if elected shall pay the dues prescribed for a Salesperson Member, unless he shall have membership as a Broker C. In any case, the employing firm shall be responsible for the payment of the dues. If during the course of the year for which said dues have been paid the employment shall end, such employing firm, subject to the provisions hereof, shall be entitled to have a new salesperson employee elected to Membership without payment of additional dues for the balance of such year.

## **ARTICLE IV Section 2.**

The annual dues for a *Salesperson Member* shall be \$320.00 a year payable annually in advance, on the first day of January.

### **Amendment to REBNY Constitution**

New applicants will receive provisional membership pending action by the Admissions Committee. The Admissions Committee must review a new member's application no later than 60 days from receipt of the application. In the event that the Admissions Committee does not reject the applicant, then the provisional membership shall become full membership. A provisional member shall have the full rights and obligations, during the 60-day period, of full membership.
